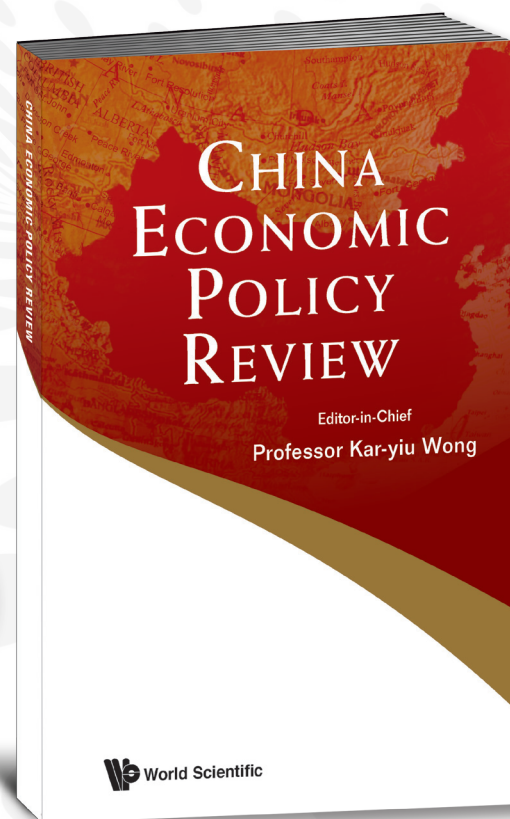

Aims & Scope

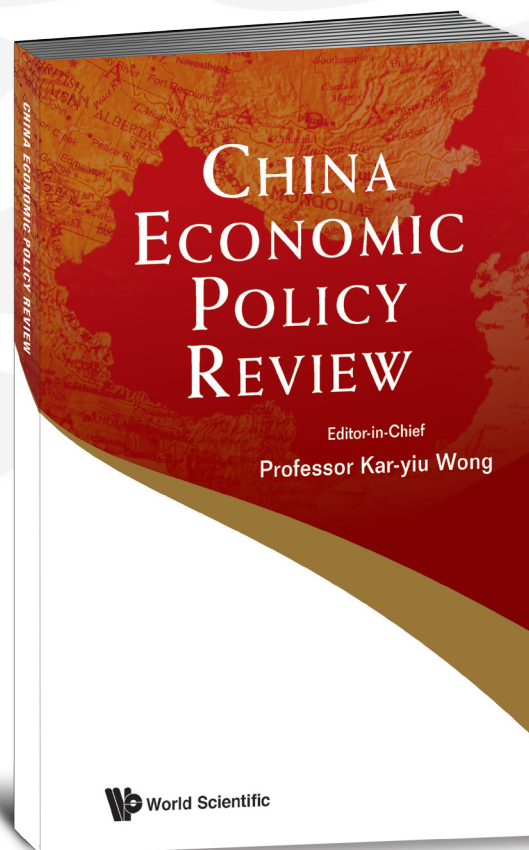
