Graduate students are encouraged to submit their papers to the conference. We plan to have a certain number of sessions for graduate students.

Each session will last for 2 hours, consisting of four papers (between three and five papers are possible), one chair (not necessarily the same as the session organizer but should not be one of the presenters or discussants), and the corresponding discussants. Please submit a proposal for one or two sessions to Professor [Sven Arndt](#) by **February 28, 2006**. The proposal should include an explanation of the theme and all papers to be presented. The proposal should also give the e-mail and postal addresses, affiliation, phone and fax numbers of the organizers and all participants to be included.
